Requirements To Apply:

1. State of Florida Minimum Standards (Certificate of Compliance)

2. State of Florida Emergency Medical Technician and/or Paramedic License

4. FireTEAM Test • www.nationaltestingnetwork.com
5. Emergency Vehicle Operators Course (EVOC) - Typically offered through EMT school.

6. **Driver's License:** A valid Florida Driver's License must be obtained prior to the start of employment. Candidates must also have a good driving record.
7. Must be a non-user of tobacco or tobacco products for at least 1 year immediately preceding application.

SCFD Hiring Process

The following is a list of typical steps taken during the SCFD hiring process. Additional information will be provided during an active application process.

1. **Job Posting:** Applications for Firefighter/EMT or Paramedic are accepted only during a job posting for Firefighter/EMT or Paramedic. Seminole County Human Resources publishes all job postings. About the Department:

In 1974, the Seminole County Department of Public Safety, EMS/Fire/Rescue Division (SCFD) was created to serve unincorporated Seminole County. SCFD began with 10 stations and has grown to 18 stations located throughout Seminole County. SCFD also provides services to the Cities of Altamonte Springs and Winter Springs. Seminole County has a population of over 400,000 citizens and responds to over 29,000 alarms annually.

What the Job Entails:

A professional firefighting and medical services career with SCFD requires an “All Hazards” response to protect life and property. Duties include, but are not limited to, combat firefighting, emergency medical services, rescue, hazardous materials, domestic terrorism, public education and fire prevention activities.
