## Violations Comments

Violation #21. Hot holding temperatures

Food held just below required temperatures while being hot held.

Corrective Action Required: Ensure that hot held food is kept at 135 degrees F (57 degrees C) at all times during hot holding.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.

Violation #44. Equipment & linens: stored, dried, & handled

Large floor and table equipment not covered when not in use.

Corrective Action Required: Provide a protective layer, such as a plastic cover, to equipment such as mixers and meat slicers when not in use.

CODE REFERENCE: 64E-11.003(4). Utensils and equipment must be cleaned, sanitized and air dried prior to storage. Utensils, equipment, and linens must be properly cleaned and stored.

## General Comments

Inspection Satisfactory. Equipment coverings and hot holding temperature infractions must be abated by the next routine inspection.
